Installation

General Information

1. Refer to the separate Husky 715 pump instruction manual for detailed warnings and information on air exhaust ventilation, air and fluid line installation, operation, maintenance, service, and accessories.
2. Use a compatible, liquid thread sealant on all male threads. Tighten all connections firmly to avoid air or fluid leaks.
3. Assemble the Cover Kit and Agitator Kit as shown on page 3. If you are not using the agitator, be sure the agitator bung is plugged with the cap (11).
4. Position the feet of the Husky 715 pump over the mounting studs (5a) on the pail cover. Secure with the washers, lockwashers and nuts (4,1,3) provided. See page 3.

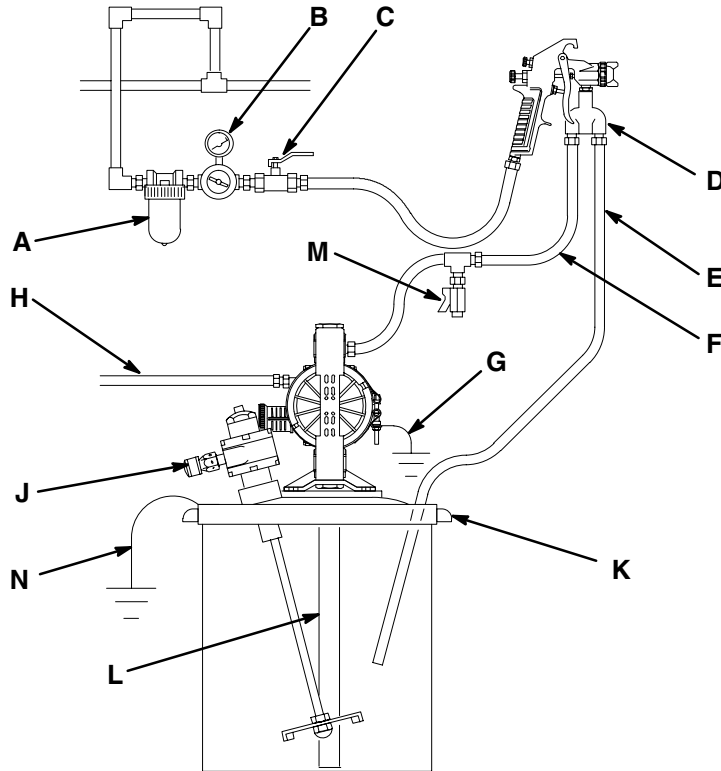


FIRE AND EXPLOSION HAZARD

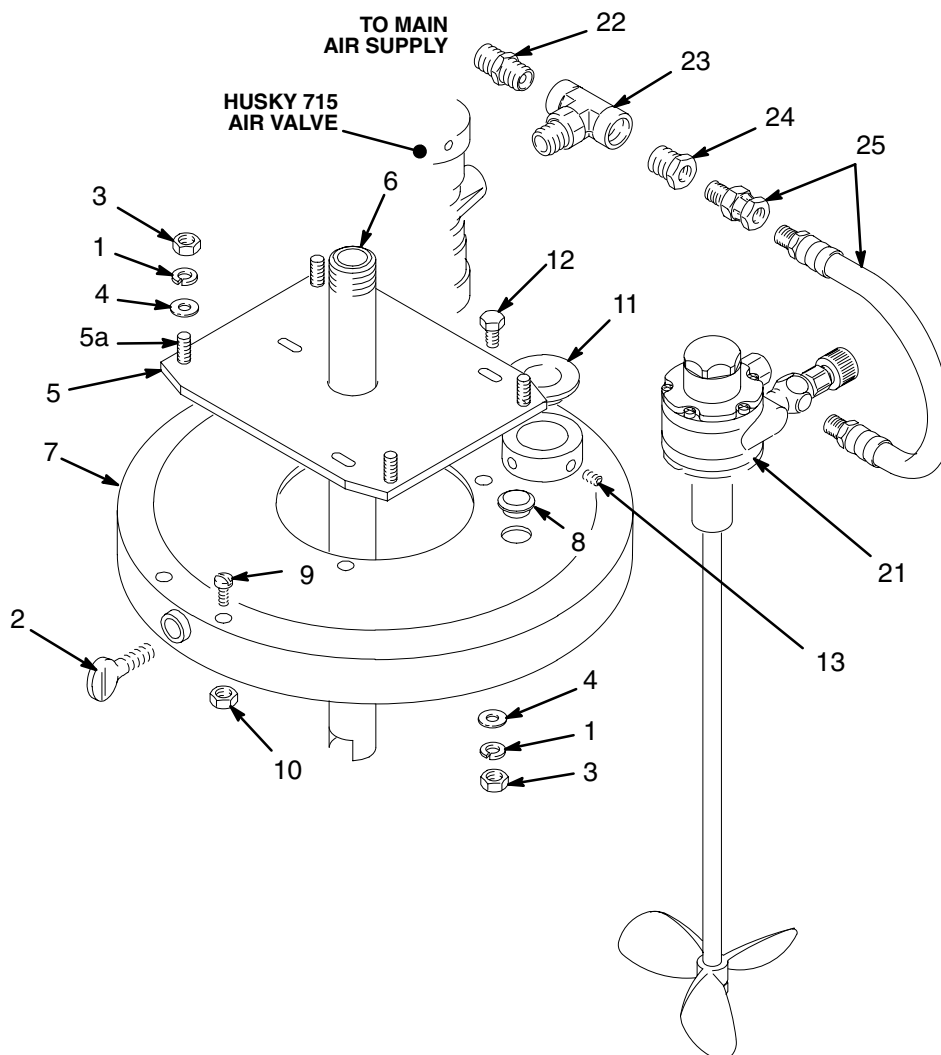

If the claimed defect is verified, Graco will repair or replace free of charge any defective parts. The equipment will be returned to the original purchaser transportation prepaid. If inspection of the equipment does not disclose any defect in material or workmanship, repairs will be made at a reasonable charge, which charges may include the costs of parts, labor, and transportation.

THIS WARRANTY IS EXCLUSIVE, AND IS IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTY OF MERCHANTABILITY OR WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE.
