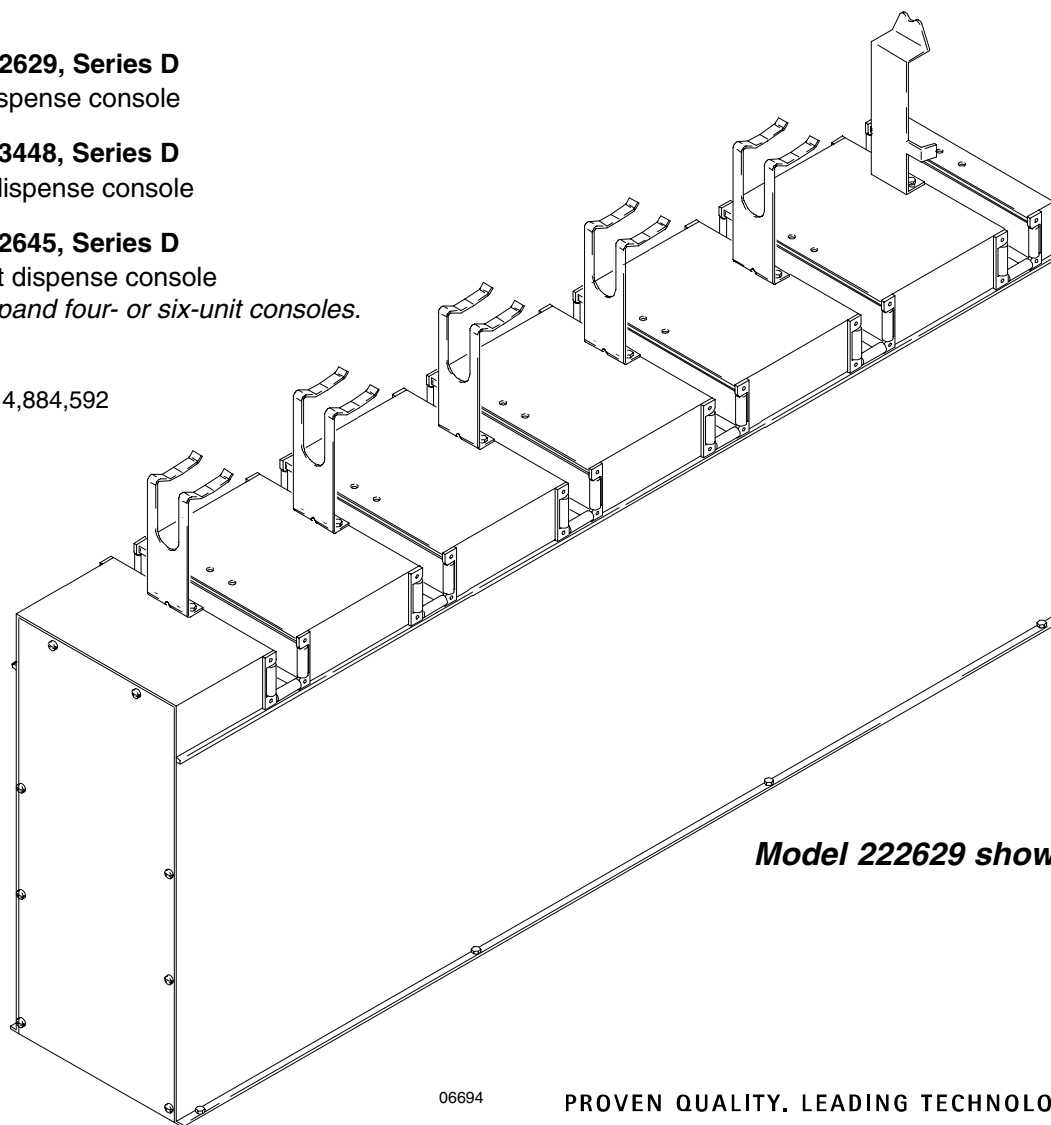

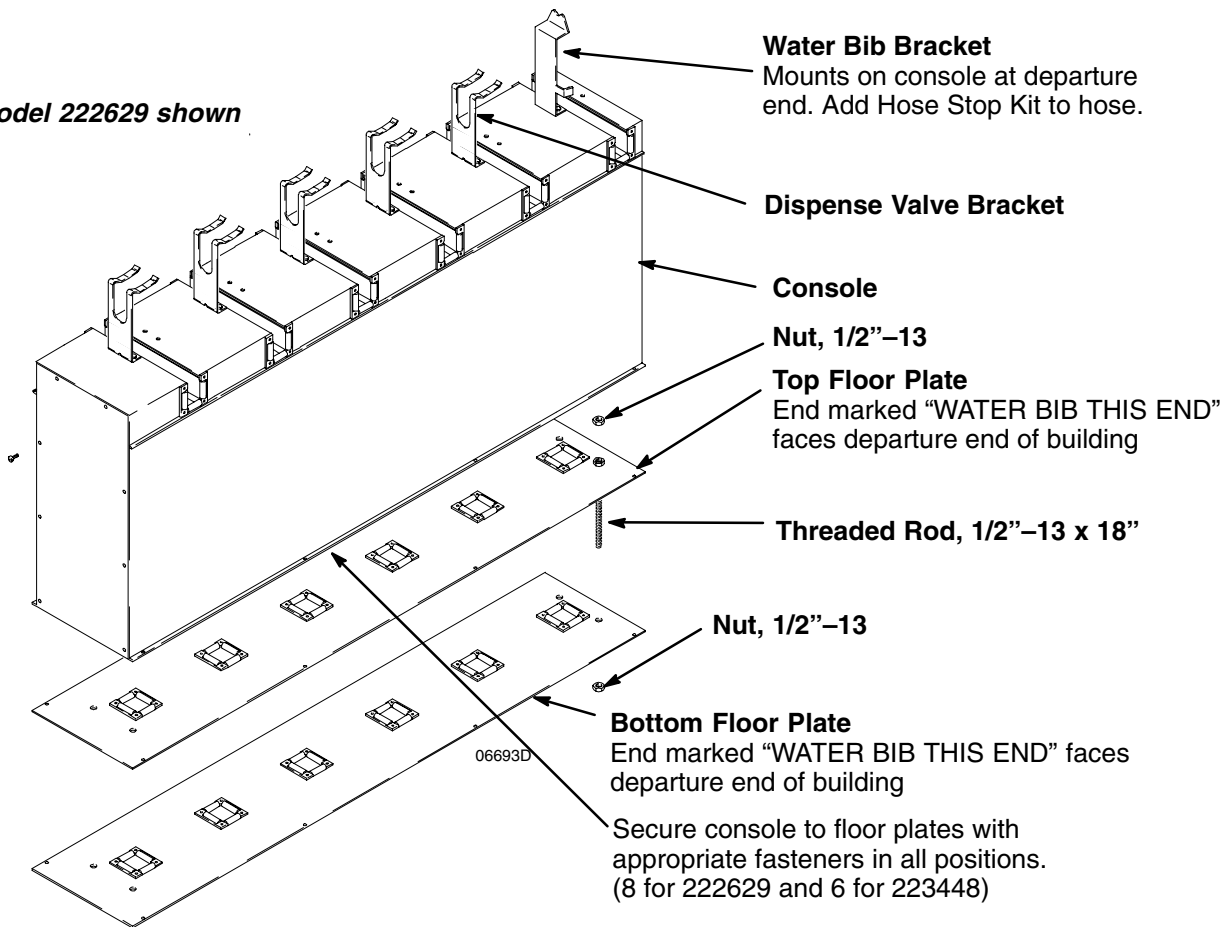

# Installation

## Install the Four or Six Unit Dispense Console

**NOTE:** The end of the console which is used for the water bib must face the departure end of the building.

**NOTE:** Order and install one Hose Stop Kit, part no. 218341 for each water bib hose.

1. Install the bottom floor plate and top floor plate, using the threaded rods and nuts as shown above.
2. Place the console over the floor plates.
3. Use appropriate fasteners (not supplied) to secure the console to the top floor plate.

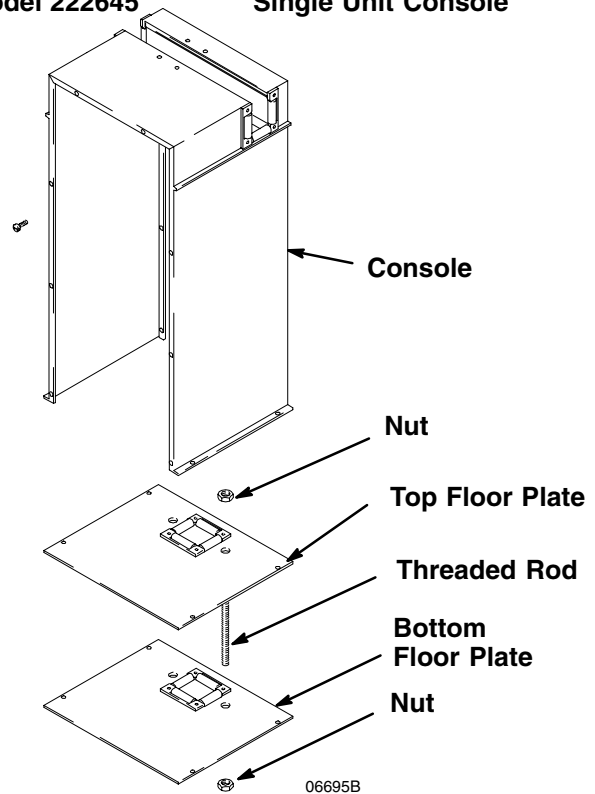
## Add a Single Unit Dispense Console

1. Remove the end panel of the four or six unit Dispense Console. Install the bottom floor plate and top floor plate using the threaded rods and nuts as shown to the left.
2. Place the console over the floor plates.
3. Use appropriate fasteners (not supplied) to secure the console to the top floor plate.
4. Reinstall the end panel.

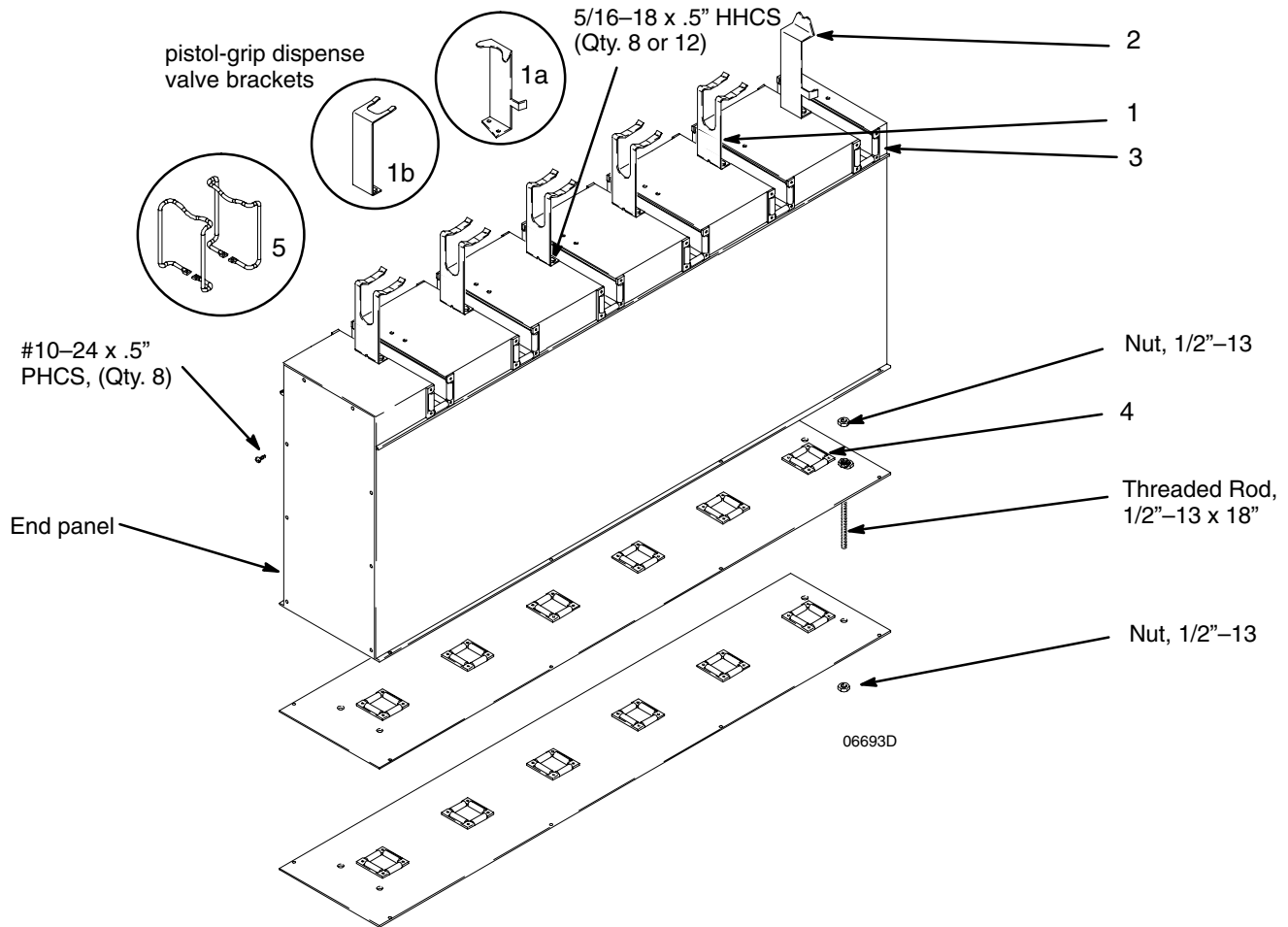

If inspection of the equipment does not disclose any defect in material or workmanship, repairs will be made at a reasonable charge, which charges may include the costs of parts, labor, and transportation.
