FOR VALUEMIX PROPORTIONERS

Mix Manifold Bracket Kit

Part No. 243823

To hang the mix manifold from an operator's belt or from a hook. Includes bracket and attaching hardware.

Installation

1. Remove the one long screw (A) from the mix manifold's fluid regulator housing and regulator mounting plate. See Fig. 1.
2. Refer to the parts drawing at right. Install the bracket (1) as shown. Secure with the screw (2), spacer (3), washer (4), and nut (5).
3. Install the strap (6) through the slot on the bracket and tighten as necessary.

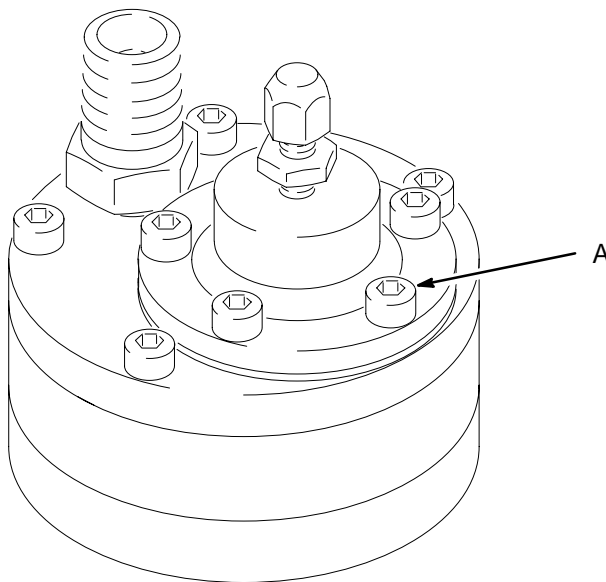

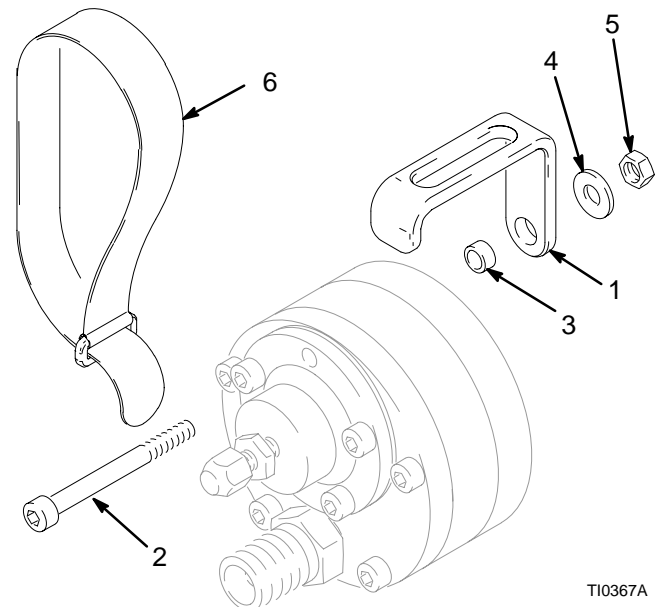

Nor shall Graco be liable for malfunction, damage or wear caused by the incompatibility of Graco equipment with structures, accessories, equipment or materials not supplied by Graco, or the improper design, manufacture, installation, operation or maintenance of structures, accessories, equipment or materials not supplied by Graco.

This warranty is conditioned upon the prepaid return of the equipment claimed to be defective to an authorized Graco distributor for verification of the claimed defect. If the claimed defect is verified, Graco will repair or replace free of charge any defective parts. The equipment will be returned to the original purchaser transportation prepaid. If inspection of the equipment does not disclose any defect in material or workmanship, repairs will be made at a reasonable charge, which charges may include the costs of parts, labor, and transportation.

THIS WARRANTY IS EXCLUSIVE, AND IS IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTY OF MERCHANTABILITY OR WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE.
