Installation

Pressurized Equipment Hazard

To reduce the risk of an injury, follow the **"Pressure Relief Procedure"** in your gun manual before installing this kit.

Hold the front end of the gun up and trigger the gun while removing the nozzle to help drain the gun and prevent any paint or solvent left in the gun from entering the air passages.

1. Flush the gun according to instructions in your gun manual. Relieve the pressure.

2. Remove the air cap assembly. Point the front end of the gun up and squeeze the trigger while removing the fluid nozzle.

Do not operate the gun with a damaged electrode. Carefully guide the electrode through the hole in the fluid nozzle before tightening the nozzle.

- 3. Check that the conductive o-ring (2a) and fluid seal o-ring (2b) are in place on the new nozzle. See the parts drawings on page 2.
- 4. Trigger the gun while installing the new fluid nozzle (2). Tighten until the fluid nozzle seats in the gun barrel (1/8 to 1/4 turn past hand-tight).

- 5. Place the diffuser (1) onto the fluid nozzle (2).
- 6. Install the air cap (3) over the fluid nozzle (2), being careful not to damage the electrode.
- 7. Screw the gun's retaining ring over the air cap, onto the spray gun.
- 8. Tighten the retaining ring until it is snug, allowing the air cap to turn with resistance. If too tight, the spray pattern will be distorted.
- 9. Test the gun resistance as instructed in your gun manual.





Air Flow Adjustment

When using the round pattern kits, in most applications it is desirable to use a very low air flow through the air cap while maintaining enough pressure at the gun inlet for full electrostatic power (about 40 psi [0.3 MPa, 2.8 bar]). This can be achieved by using the gun's fan air valve to restrict the air cap air. The pattern width cannot be adjusted when using the round pattern kits.

NOTE: The round pattern kits are not recommended for flow rates greater than 7 oz/min (210 cc/min).
