Installation



Use chemical or petroleum compatible sealant on standpipe threads before assembling into pump inlet port. Failure to seal threads will cause difficulty in priming. See **Parts**, page 4.

- 1. Determine correct length of standpipe.
- Install bung adapter (19) into tank. Insert threaded end of standpipe into tank through bung adapter (19) until threaded end of pipe rests on bottom of tank.
- 3. Mark length of standpipe at top of bung adapter (19).
- 4. Remove standpipe and cut pipe 1 in. (25.4 mm) shorter than marked length.
- 5. Tighten bung adapter (19) into tank. Insert standpipe through bung adapter and position pump in desired position for convenient operation. Tighten two locking screws (24).
- 6. Apply sealant to both ends of hose. Assemble hose to pump and assemble nozzle to other end of hose.

Operation

CAUTION

For Model 260406, all fluids pumped must be compatible with fluoroelastomer, aluminum, and EPDM. For Model 260407, all fluids pumped must be compatible with aluminum and buna-N.

- 1. Insert nozzle into container being filled. Cycle handle to pump fluid.
- 2. Always stow nozzle in nozzle holder to prevent contamination from entering hose and nozzle.
- 3. If pump fails to prime, remove plug on pump outlet and pour 8 oz (0.24 liter) of compatible fluid into the pump.

Maintenance

Flushing pump

Proper flushing of pump after use with herbicides and chemicals is essential for long service life. Many herbicides dry quickly and will make pump inoperative if allowed to dry inside pump.

CAUTION


For Model 260406, all fluids pumped must be compatible with fluoroelastomer, aluminum, and EPDM.

For Model 260407, all fluids pumped must be compatible aluminum and buna-N.

- 1. Remove pump from tank and insert suction pipe into water or chemical agent recommended by chemical manufacturer.
- 2. Operate pump until fluid discharge is free of chemical.
- 3. For extended storage after use with herbicide or chemical, flush pump, and fill with diesel fuel.
